From 2008 to 2010 she served as Head of the Department of Social Administration at Democritus University. Her former academic position was head of the Department of Sociology of Crete University.

For a long time she collaborated with the International Social Science Council (based at UNESCO) in the context of the CROP Programme (Comparative Research Programme on Poverty). From 1998 to 2006, she was a member of the CROP Scientific Committee and from 2003 to 2006 she was Vice-Chair of this committee. She also participated in the editorial board for the drafting of "Poverty. An international glossary" (London: Zed Books, 2007). In January 2010 she was officially appointed CROP Fellow by the International Social Science Council. In spring 2013 she was CROP visiting researcher at the University of Bergen (CROP/UiB Global), and between 2017 and 2019 she served again as member of the CROP Scientific Committee.

From 1997 to 2005 she was a member of the Scientific Council of the European Foundation on Social Quality (Amsterdam) and from 1999 onwards, a member of the international advisory committee of the *European Journal of Social Quality* (renamed into *International Journal of Social Quality*, Berghahn Journals). She is a founding member of the Hellenic Social Policy Association and served as president of HSPA for two terms.

She has served in various scientific committees and expert networks and has directed (and participated in) a large number of research projects funded by Greek governmental bodies (e.g. the Ministry of Education, the Ministry for the Environment, Planning and Public Works and the Ministry of Health and Social Welfare), as well as by the European Commission and other European agencies. In the period 1991-96, she collaborated with the "Institut Arbeit und Technik" (Germany) on various research projects on socio-economic development and policy issues under the FAST Programme of the European Commission. She also served as national expert reporting on issues of social reform to DG Employment & Social Affairs (EU Commission). For a number of years she participated in a national experts group providing analytical support to DG Employment and Social Affairs on assessing the socio-economic impact of social

protection reforms (in the fields of pensions, health and long-term care, ASISP network).

She served as member of the National Research Council of Greece and of the Sector Council for Humanities and Social Sciences (at the General Secretariat for Research and Technology), as well as of the "Steering Group on Human Resources and Mobility in the European Research Area" (European Commission). In 2000-01 she served as member of the "Steering Scientific Committee" for the project "National Atlas of Health and Social Care in Greece" (Ministry of Health), and in 2001 she chaired this committee. During 2001-03 she conducted research on social care services reform and performance indicators (commissioned by the Ministry of Health and Social Welfare).

During her academic career she has collaborated with a number of universities and research centres abroad in the context of joint undergraduate and postgraduate teaching programmes (one of these was MESPA - Masters in European Social Policy Analysis Programme - which constituted a joint programme of study in social policy analysis, in a European context, offered by eight collaborating European Universities, financed under the Socrates/Erasmus programme of the European Commission, between 1990 and 1998). Recently (May 2018) she organized a workshop on "South European welfare states: The impact of the crisis and post-crisis challenges" in the context of the postgraduate programme "Master in Public Policy and Social Change (University of Turin / Collegio Carlo Alberto).

She has participated, as invited speaker, in many international conferences. Her long-term research-experience as well as her publications concern the following areas:

- social theory,
- social stratification and social mobility;
- socio-economic development (local/regional development) and technological change;
- employment structures and labour markets;
- socio-economic inequality, poverty and social exclusion;
- comparative analysis of social protection systems in South Europe (and the broader Mediterranean Area), with an emphasis on social insurance, health and long-term care;
- performance assessment of social services and social quality indicators.
